It takes approximately 35 days for the payment to post to the utility account.</p> <p>Crisis Assistance:  OHC provides connect, reconnect, or prevents disconnection with electric or gas accounts. Also, if you are at 10% or below in propane (and are not allowed to charge propane), OHC can assist with minimum delivery.</p> <p>Follow Up:  Once your application is submitted, please do not call to check on your application.
